Purchased coffee urns and walkie talkies (2 were lost) to save money in the future. One of the two cash registers needs to be serviced. Turned over set of tapes to committee. 66 Early Bird Reg. 600 regular Reg – sold out. Banquet sold out. Lost money since cost of banquet was \$29.99. Jewelry Vendor left early stated poor sales. Design of Freedom in breach of contract. **Question: Did they submit a vendor ID # and has this vendor been reported to World?** Sold banquet at \$20. Total sold 140. **Question: How many were sold at the Convention? (Pre sale was to be \$20 at the Convention \$25. This question could not be answered.)** A pre-paid debit card was opened under an individual's name. **Question: What has happened to the card? It is being turned over to the committee with a balance of a few dollars left on it.** Saturday and Sunday Brunch expense was \$1,584.00. **Question: What**

was made for brunch? Programming has the tickets and there is no line item in our records stating what was made. Convention expenses were not totaled. Merchandise sold out. Question: Do you have a report from Registration? Do you have the hard copy registrations and info? Where are they if they are not in your possession? PO Box 151 is paid in full for another year. The account remains open with \$1000.49 seed money. Point of Information provided here – the committee does not have the decision making authority to hold seed money for the next committee. All revenue is to be turned over to the Region at the end of the Convention.
